Far West members financially support their association through a dues assessment based upon their company's sales activity in the states of Washington, Idaho, Oregon, Utah, and Nevada (Northwest region). Entities with distinct names can be included within the member ship of a member company as long as a majority (> 50%) ownership remains within the member company; however, only one vote shall be recognized since the company is recognized as one member with more than one name. The combined gross sales amount within the Far West Region will constitute the category or level of membership dues to be paid. Business volume includes gross invoice billings for fertilizer, fertilizer products, agricultural crop protection products, all forms of seed, minerals, soil amendments, auxiliary soil chemicals, and custom fees for all offices, branches, and /or company units. Member classifications are based upon annual business volume generated in the Northwest Region. Calculate 2019 membership dues using your company's 2018 sales volume for our five state area. Check the appropriate member class and return this signed form and payment to the Far West Agribusiness Association office.
